IMPORTANT CONDITIONS:

The applicant should ensure the following:

1. **MINIMUM EDUCATIONAL QUALIFICATION:** A candidate must hold the required educational qualification from a University / Institution recognized by appropriate Statutory Authority and should be regular and full time, on the closing date of receipt of applications as prescribed against the respective post.
2. All the applicants must fulfill the essential requirements of the post and other conditions stipulated above. They are advised to satisfy themselves before applying, that they possess at least the essential qualifications laid down for the post. **No inquiry asking for advice as to eligibility will be entertained.**
3. **AGE:** Not exceeding as indicated against the respective posts as on closing date of advertisement published in the Employment News. The upper age limit for advertised posts on direct recruitment basis is relaxable for candidates belongs to SC/ST/OBC category and other special categories of personnel as per the Instructions/Rules/Guidelines issued by Govt. of NCT of Delhi / GOI from time to time.
4. Suitable Categories of Benchmark Disability as per functional requirements of DPCC: **CAT (a)** – Deaf & Hard of Hearing and **CAT (b)** – Locomotor Disability (OL, BL, OA) including Leprosy Cured (OA, OL, BL), Dwarfism, Acid Attack Victims and Muscular Dystrophy.
5. **The posts of AEEs are Exclusively Reserved for OBC (NCL) Delhi and PwBD. Application(s) received for this post from other than the said category's candidates, will not be entertained.**
6. The number of vacancies are tentative and may increase or decrease at sole discretion of DPCC.
7. Candidates belonging to OBC category but coming in the 'CREAMY LAYER' are not entitled to get benefit of OBC reservation and age relaxation.
8. The reservation of posts for OBC communities of Delhi and PwBD will be as per the prevailing Orders / Guidelines issued by GNCTD and Govt. of India.
9. The crucial date for determining the age limit shall be the closing date for receipt of applications from candidates.
10. Candidates working in Government, Semi-Government Organization/Public Sector Undertakings and Autonomous Bodies should apply through proper channel or furnish 'NO OBJECTION CERTIFICATE' at the time of Interview. However, in the event of difficulty in forwarding the application through proper channel/getting NOC from their parent department, candidate must submit an undertaking at the time of interview that he/she will produce proper relieving order from their organization, in case selected; otherwise, he/she will not be allowed to join.

11. The candidate must be a citizen of India.
12. In case a candidate applies for more than one post, he/she must submit separate Applications Form for each post.
13. Eligibility for Availing Reservation:
 - (i) Reservation benefits will be available to the SC/ST/OBC/EWS/PwBD & other special category candidates (where applicable) in accordance with the extant Instructions / Orders / Circulars issued from time to time by the Govt. of NCT of Delhi/ DoPT, Govt. of India. The candidate has to select the particular category while applying for the post. No request for change of Category will be entertained at any later stage.
 - (ii) The latest GNCTD/DoPT guidelines issued from time to time will be taken into consideration for final appointment.
 - (iii) Only OBC (Delhi) candidates notified by Govt. of NCT of Delhi from time to time will be given the benefit of reservation/age relaxation under OBC category. This has been further clarified by the Services Department, Government of NCT of Delhi vide Office Memorandum No. F.19(02)/2011/S.IV/Vol.I/856 dated 31/05/2021 (Annexure-V). OBC (Outside Delhi) candidates will be treated as Unreserved (UR) candidates and they must apply under the UR category. The OBC candidates must be in possession of a latest valid Non-Creamy Layer certificate along with their caste certificate on or before the cut-off date.
 - (iv) Only following two types of certificates will be accepted as valid certificates for grant of benefit of reservation to OBCs: - (a) OBC Certificate (Delhi) issued by the Revenue Department of GNCT of Delhi, on the basis of an old certificate issued to any member of individual's family from GNCT of Delhi. (b) OBC certificate issued by a Competent Authority outside Delhi to a person belonging to a community duly notified as OBC by GNCT of Delhi. This certificate should have mandatorily been issued on the basis of OBC certificate issued by Govt. of NCT of Delhi to a family member of the concerned person who had been residing in Delhi before 08/09/1993.
 - (v) No change in the Community Status already indicated in the application by a candidate for the post will be allowed.
14. The candidates must submit their applications in prescribed form along with **Annexure-1** and self-attested requisite supporting documents in hard copy through Registered Post/Speed Post/By-Hand (**Application Form submitted without relevant supporting documents, no weightage marks claimed, will be assigned**).
15. Application submitted in other form will not be accepted. No correspondence will be entertained in this regard. The application received late (after due date) in DPCC, whatsoever reasons, will not be entertained. DPCC shall not be responsible for any delay/loss due to postal or technical reasons.
16. All information submitted in the application will be verified with original documents at the time of interview. If any information provided by the candidate is found to be false or incorrect or not in conformity with the eligibility criteria, then his/her candidature is liable to be rejected/cancelled at any stage of the recruitment process.
17. Before submission of the application, candidates must check and ensure that they have filled correct details in each field of the application form. Once application is submitted, no request for change/ correction/ modification (including change of category) will be entertained or allowed under any circumstances. **Request received in this regard in any form like Fax, Email, etc. shall not be entertained and no correspondence will be made in this regard.** Candidates will be responsible for any mistake, if found in the data of application submitted by him/her.
